 We or Metrix Connect may have associations or relationships with issuers of insurance products and other financial products.

We will provide you with further information whenever we provide you with advice, which takes into account your objectives, financial situation and needs. This information may be contained in a statement of advice (**SOA**).

When you ask us to recommend an insurance policy for you, we will usually only consider the policies offered by the insurers or insurance providers that we deal with regularly. In giving you advice about the costs and terms of recommended policies we have not compared those policies to other policies available, other than from those insurers we deal with regularly.

Product disclosure statement

If I/we offer to arrange the issue of an insurance policy to you, I/we will also provide you with, or pass on to you, a product disclosure statement (**PDS**), unless you already have an up to date PDS from the insurer. The PDS will contain information about the particular policy, which will enable you to make an informed decision about purchasing that product.

We will do this on your behalf as your broker unless we tell you otherwise. |

| Will I receive tailored advice? | Maybe not in all cases. However, we may need information about your personal objectives, details of your current financial situation and any relevant information, so that we can arrange or issue insurance policies for you, or to give you advice about your insurance needs. We will ask you for the details that we need to know. |
| | In some cases, we will not ask for any of this information. If we do not ask, or if you do not give us all of the information we ask for, any advice you receive may not be appropriate to your needs, objectives and financial situation. |
| | You should read the warnings contained in any SOA, or any other warnings that we give you, carefully before making any decision about an insurance policy. |
| | Where we provide you with advice about your insurance arrangements, that advice is current at the time that we give it. We will review your insurance arrangements when you inform us about changes in your circumstances. |
| Contractual Liability and your insurance cover | Many commercial or business contracts contain clauses dealing with your liability (including indemnities or hold harmless clauses). Such clauses may entitle your insurers to reduce cover, or in some cases, refuse to indemnify you at all. You should seek legal advice before signing and accepting contracts. You should inform us of any clauses of this nature before you enter into them. |
| What information do you maintain in my file and can I examine my file? | Metrix Connect maintains a record of your personal profile, including details of insurance policies that I/we arrange for you. Metrix Connect may also maintain records of any recommendations or advice given to you. Metrix Connect will retain this FSG and any other FSG given to you as well as any SOA or PDS that we give or pass on to you for the period required by law. |

| How will I pay for the services provided? | Payment for the services I/we provide you are payable directly to Metrix Connect. For each insurance product, the insurer will charge a premium that includes any relevant taxes, charges, and levies. Metrix Connect ofter receive a payment based on a percentage of this premium (excluding relevant taxes, charges, and levies) called commission, which is paid to Metrix Connect by the insurers. In some cases, you will also be charged a fee. These will all be shown on the invoice that is sent to you. |

| | You can choose to pay for our services by any of the payment methods se out in the invoice. You are required to pay Metrix Connect within the time set out on the invoice. |
| | If there is a refund or reduction of your premium as a result of a cancellation or alteration to a policy, or based on a term of your policy (such as a premium adjustment provision), we will retain any fee we have charged you. We will also retain commission depending on our arrangements with the insurer or charge you a cancellation fee equal to the reduction in commission. |
| | When you pay us your premium it will be banked into Metrix Connect trus account. Metrix Connect will retain the commission from the premium you pay us and remit the balance to the insurer in accordance with Metrix Connect arrangements with the insurer. Metrix Connect will earn interes on the premium while it is in their trust account or Metrix Connect may invest the premium and earn a return. Metrix Connect will retain any interest or return on investment earned on the premium. |
| How are any commissions, fees or other benefits | Metrix Connect commission will be calculated based on the following formula: |

As a Steadfast Network Broker, Metrix Connect has access to member services including model operating and compliance tools, procedures, manuals and training, legal, technical, HR, contractual liability advice and assistance, group insurance arrangements, product comparison and placement support, claims support, group purchasing arrangements and broker support services. These services are either funded by Steadfast, subsidised by Steadfast or available exclusively to Steadfast Network Brokers for a fee. |
